CITY OF LAGRANGE, GEORGIA REGULAR MEETING OF THE MAYOR AND COUNCIL

May 22, 2018

The meeting was called to order by Mayor Thornton, the invocation was given by Mr. McCamey and Mayor Thornton led the Pledge of Allegiance to the Flag.

On a motion by Mr. McCamey seconded by Mr. Arrington, Council approved the minutes of the regular Council meeting held on May 8, 2018.

Ramona Holiday of Mona's Healing Growth appeared before the Mayor and Council and discussed a proposed community garden at 1015 Barton Street. Ms. Holiday reviewed the benefits of community gardens as increasing access to fresh food, increasing physical activity and improving dietary habits. No action was taken.

Ms. Threadgill presented sign variance requests for two additional wall signs for Great Wolf Lodge located at Tom Hall Parkway. Ms. Threadgill stated these additional signs represent approximate 150 square feet. Board of Planning Zoning recommended approval of the variance request to allow two additional wall signs. On a motion by Mr. McCamey seconded by Mr. Arrington, Council voted unanimously to call for a public hearing on June 12, 2018.

Ms. Threadgill presented a request for a sign variance to increase the number of wall signs for Walmart located at 803 North Franklin Road. Ms. Threadgill stated the applicant requested an extra wall sign for their new online ordering program. Board of Planning Zoning recommended approval of the variance request to allow one additional wall sign. On a motion by Mr. McCamey seconded by Mr. Gore, Council voted unanimously to call for a public hearing on June 12, 2018.

On a motion by Mr. McCamey seconded by Mr. Arrington, Council voted unanimously to deny a notice of claim for damages filed on behalf of Kazianna Chapman.

On a motion by Mr. Arrington seconded by Mr. Mitchell, council voted unanimously to amend the proposed 2018-2019 City Budget and appropriate \$20,000 for the Ark Refuge for utilities.

On a motion by Mr. Gaskin seconded by Mr. Gore, Council voted unanimously to call for a public hearing on June 12, 2018 to gain citizen input on the 2018-2019 City Budget.

On a motion by Mr. Mitchell, seconded by Mr. McCamey, Council voted unanimously to declare the following items as surplus:
