

**CITY OF LAGRANGE
COMMERCIAL ELECTRIC SERVICE
Revised January 1, 2011**

AVAILABILITY:

Throughout the City's service area from existing lines of adequate capacity.

APPLICABILITY:

To all electric service of one standard voltage required on the customer's premises, delivered at one point and metered at or compensated to that voltage. Customers with a demand in excess of 5000 KW may require additional generation and/or facilities charges as determined by the City.

TYPE OF SERVICE:

Single or three phase, 60 hertz, at a standard voltage

MONTHLY RATE - Energy Charge Including Demand Charge:

Base Charge	\$25.00	
All consumption (KWH) not greater than 200 hours times the billing demand:		
First 1500 KWH.....	12.5 cents per KWH	
Next 8500 KWH.....	11.2 cents per KWH	
Next 190,000 KWH.....	9.2 cents per KWH	
Over 200,000 KWH.....	8.2 cents per KWH	
All consumption (KWH) in excess of 200 hours and not greater than 400 hours times the billing demand.....		1.6 cents per KWH
All consumption (KWH) in excess of 400 hours and not greater than 600 hours times the billing demand.....		1.2 cents per KWH
All consumption (KWH) in excess of 600 hours times the billing demand.....		0.8 cents per KWH

Minimum Monthly Bill: \$25.00

FUEL ADJUSTMENT:

The amount calculated at the above rate will be increased under the provisions of the City's effective Fuel Adjustment.

DETERMINATION OF BILLING DEMAND:

The Billing Demand shall be based on the highest 30-minute KW measurement during the current month and the preceding eleven (11) months.

For the billing months of **June** through **September**, the Billing Demand shall be the greatest of:

- (1) The current actual demand, or,
- (2) Ninety-Five percent (95%) of the highest actual demand occurring in any previous applicable summer month (June

through September), or,
(3) Sixty percent (60%) of the highest actual demand occurring in any previous applicable winter month.

For the billing months of **October** through **May**, the Billing Demand shall be the greater of:

- (1) Ninety-five percent (95%) of the highest summer month (June through September), or,
- (2) Sixty percent (60%) of the highest winter month (October through May, including the current month).

LEVELIZED BILLING OPTION:

Commercial customers with a good credit history and expected monthly billings of less than or equal to \$5000 may be offered the option of levelized billing. Signup will be limited to the months of September through May unless otherwise approved by the City. Details of this billing option are available from the City's Customer Service Division.

ROUND-UP

Customers that do not notify the City of their desire to opt-out will have the total of their utility charges rounded up to the next whole dollar. The proceeds of this round-up will be used to assist low income customers pay their utility bills or as otherwise directed by the LaGrange City Council.

OFF PEAK DEMAND:

For customers that have a demonstrated off-peak demand that is significantly higher in the opinion of the city than their on-peak demand, the billing demand under this rate shall be modified using a mutually agreeable method negotiated between the customer and the City.
